Access to Announcement Room

You should always carry your Meal Function Card while at the tournament. Please show your card when asked. You may not invite friends (or high school recruits) who do not have these cards. Instead, suggest that they visit the coffeehouse, use Hardees, and come to your rounds.

Each participating school has a access code for one of the xerox machines. Cost is 4.5 cents per copy, but \$40.00 is paid up front. No refunds. Use more than 888 pages? Pay the 4.5 cents per page to UNI. Please be fair to other users; limit your copy work when others are in line. Access throughout tournament, 7:00 a.m.–midnight.

Campus parking during tournament

On Saturday, don't unload evidence until announcements are complete. Drive your vans to Sabin (entry from either Maucker Union or other side) and/or Business (entry easiest from west side). Large dollies will be managed by UNI students to help you transport to the buildings. From there, you'll have to lug them yourselves. As quickly as possible move your van so others can be close. Parking is permitted in any lot on Saturday and Sunday (but not next to Maucker!) and in the large parking lot immediately south of the Business Building on Monday and Tuesday.

Evidence Shift from one building to the other

If you shift from one building to the other, the large dollies will be in operation to assist you. Jeff Fuhrman will coordinate members of Delta Upsilon, Kappa Sigma, Pi Kappa Alpha, Sigma Phi Epsilon, Sigma Alpha Epsilon, Pau Kappa Epsilon, and Delta Chi in assisting you. Again, this is between, not into the buildings. We'll have three of these dollies in operation at all times, and our people will be told not to release them to any team. On Tuesday morning, the dollies will be located at each of the rooms in Wright Hall, so that the winning team's evidence can quickly be moved into Maucker.

Evidence Storage

You may leave evidence in the room where you debated last on Saturday and Sunday nights. However, you probably ought to put away any briefs, etcetera, since our cleaning staff is sometimes diligent. They won't bother briefcase, boxes, and carrying cases if they are stacked in a room.

Tuesday Evidence

After Monday's rounds, load your evidence into your vans, since on Tuesday rounds are in Maucker or Wright.

Smoking on our campus

The smoke-free environment is winning the battle against smokers rights. There are few places where smokers are welcome on our campus. One of them is in the smoker's bays immediately outside the Expansion area lobby. They're clearly marked, and you are requested to utilize them or outside for smoking. You were very helpful during the fall tournament. Please respect our law.

Tournament Team Pictures

Sunday after round four until before round six, team pictures will be made. They'll mail color prints within a week. The company is good, and if you buy enough copies, we don't have to pay for the NDT prints for the post tournament book. These copies will cost \$8.00 (8x10) and \$7.00 (5x7).

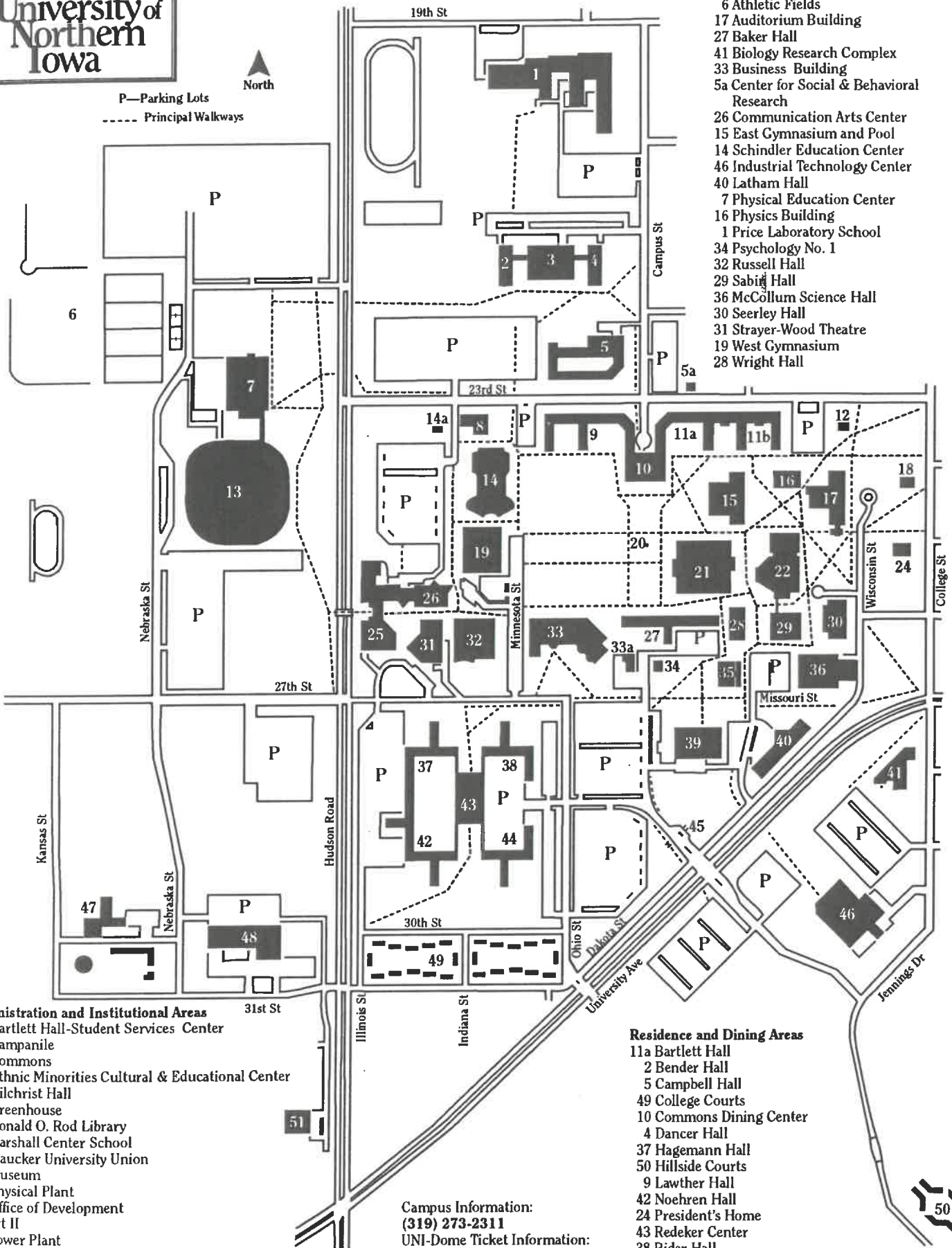
